#### FOUNDRIES AND FORGE SHOPS FOR MANUFACTURE OF HEAVY MACHINERY

\*139. **SHRI N. C. SEKHAR** (ON BEHALF OF **SHRI BHUPESH GUPTA**) : Will the Minister for COMMERCE AND INDUSTRY be pleased to state :

(a) whether it is a fact that some foreign firms have offered to prepare detailed project reports on the setting up of Foundries and Forge Shops for the manufacture of heavy machinery in the country ; and

(b) if so, what decision has been taken by Government in the matter ?

**THE MINISTER FOR HEAVY INDUSTRIES** (**SHRI M. M. SHAH**) : (a) We have invited offers for the preparation of project reports for these purposes and some offers have been received.

(b) These offers are still under consideration by the National Industrial Development Corporation Private Ltd.

**SHRI N. C. SEKHAR :** May I know, Sir, the names of the firms from which the offers were received ?

**SHRI M. M. SHAH :** There are different countries from which nine offers were received.

**SHRI N. C. SEKHAR :** May I know the names of those countries ;

**SHRI M. M. SHAH :** Of the nine offers, one has been received from Italy, one from Japan, one from Czechoslovakia, two from East Germany, one from West Germany and three from England.

##### PRICE AND EXPORT OF MOTOR SPIRIT

\*131. **SHRIMATI VIOLET ALVA :** Will the **MINISTER FOR WORKS HOUSING AND SUPPLY** be pleased to state whether Government propose to reduce the price of motor spirit to encourage transport facilities ?

**THE MINISTER FOR WORKS, HOUSING AND SUPPLY** (**SARDAR SWARAN SINGH**) : The price of motor spirit is fixed by the oil companies in consultation with Government after taking into account f.o.b. Gulf price, transportation, handling and other distribution charges. It is, therefore, not possible for Government to effect any general reduction in the price of motor spirit in order to encourage transport facilities.
