age was about 10,000 per month; in 1955, it was 20,000 per month, and during the last seven months the average is nearly 30,000 per month.

SHRI H. C. DASAPPA: May I know, Sir, whether on the whole our exports have increased relatively speaking as compared to Japan?

MR. CHAIRMAN: Upward or downward trend?

SHRI D. P. KARMARKAR: Sir, I could not exactly follow what my friend meant compared to Japan?

SHRI H. C. DASAPPA: May I know, Sir, whether our exports to these countries have kept pace with the increase which the Japanese have made?

- SHRI D. P. KARMARKAR: No, Sir. We are as compared to going down in some areas Japan. And it has been a , source of worry.
- SHRI H. C. DASAPPA: May 1 know, Sir, what accounts for the betterment of the Japanese position as compared to India's?
- SHRI D. P. KARMARKAR: Sir, as my hon. friend knows, it is selling technique, and there are some facilities which they give as compared with our own exporting merchants here in India. The position is not hopeless, and we are trying to make up the Joss.
- SHRI H. C. DASAPPA: Will they consider improving the business technique and bringing it up to date, because it looks as though it is a little out-of-date?
- Shri D. P. KARMARKAR: Yes, Sir, I agree with my friend that it is a little out-of-date in some respects, and we do lack some techniques.....

SHRI KISHEN CHAND: May 1 know from the hon. Minister whethei it is due to lower prices quoted by Japan for the same quality or stuff that we are losing our foreign markets; and if so, what steps have been taken by our country to lower our cost of production?

SHRI D. P. KARMARKAR: Sir, the matter depends upon many considerations.
Sometimes, it is a question of prices; sometimes, it is a question of mutual accommodation, and sometimes, it is a question of packages. Sometimes, it is also a question of trade practices. All these are interlinked, as my hon. friend knows it.

The gentleman who has been referred to is a well-known producer in America. He was thinking of producing a film on Gandhiji's teachings, not for bringing Gandhiji imself into the picture. He came here and consulted us. We said "It is a very good idea." And we thought that if there was any necessity, we could look into the question of giving him further facilities. But he has made no further move in the matter.

SHRI BHUPESH GUPTA: May 1 know, Sir, if Gandhiji's teachings have been followed by his other disciples who are in the Cabinet today?

MR. CHAIRMAN : That has nothing to do with this question.
