SHRI K. D. MALAVIYA: It is a difficult problem. The Council of Scientific and Industrial Research examined this question and then referred it to a committee. That committee made certain recommendations and on that basis some fresh points are' being considered. So, the report has not yet been submitted.

SHRI S. N. MAZUMDAR: If the village is sinking, may I know whether any arrangement has been made to shift the people residing in that village to a safe place and whether the hon. Minister has any information as regards that?

SHRI K. D. MALAVIYA: So far as security and shifting of those people are concerned, that is the job of the State Government. We are concerned with examining the geological conditions under which the sinking is reported to have occurred. Now, most probably next month when the rains abate we shall send our party who will report to us. Then only we will be able to know what the position is.

SHRI GOPIKRISHNA VIJAIVAR-GIYA: How much area is sinking? Is it big or is it only a small area?

SHRI K. D. MALAVIYA: We have no information

### RAILWAY AND POSTS AND TELEGRAPHS EMPLOYEES IN THE TERRITORIAL ARMY

- 113. SHRI M. GOVINDA REDDY: Will the Minister for DEFENCE be pleas ed to state:
- (a) how many Railway and Posts and Telegraphs employees joined the Territorial Army for training during 1955; and
- (b) what was the period and what were the timings of such training?
- THE MINISTER FOR DEFENCE ORGANIZATION (SHRI MAHAVIR TYAGI): (a) 133 Railway employees and 121 Posts and Telegraphs employees were recruited to the Territorial Army during 1955.
- (b) Training in the Railway and P. and T. units of Territorial Army is imparted for 30 days continuously every year. Training is arranged in convenient batches throughout the year to prevent dislocation of the normal civil work done by these employees.

# CENTRAL GOVERNMENT SERVANTS IN THE TERRITORIAL ARMY

- 114. SHRI M. GOVINDA REDDY: Will the Minister for DEFENCE be pleas ed to state:
- (a) the number of Central Government servants other than those of the Railways and the Posts and Telegraphs Department who joined the urban units of the Territorial Army during 1955 for training; and
- (b) the duration and timings of sach training?
- THE MINISTER FOR DEFENCE ORGANIZATION (SHRI MAHAVIR TYAGI): (a) 420 such Government servants were recruited during 1955.
- (b) Territorial Army personnel are liable to undergo recruit training in the first year and annual training every year. Training is given by the units under local arrangements. Training in the urban units, other than P. and T. and Railway units, is given on a part-time basis, outside office hours and on Sundays and other holidays. Every lour hours of training is counted as a day. The period of recruit training is 32 days (128 hours) of which at least four consecutive days have to be spent in a camp. The period of annual training is subject to a minimum of 30

days (120 hours) and a maximum of 60 days (240 hours) including embodiment in an annual camp for not less than four consecutive days.

#### CHIRAGH DELHI FORT, DELHI

- 115. SHRI M. VALIULLA: Will the Minister for EDUCATION be pleased to state:
- (a) whether it is a fact that the wall of Chiragh Delhi Fort, one of Delhi's ancient monuments, near Kalkaji is in a crumbling state; and
