IRON AND STEEL CONTROL EQUALISATION FUND TRANSACTIONS

- ♦358. SHRI M. GOVINDA REDDY: Will the Minister for COMMERCE AND INDUSTRY be pleased to state:
- (a) whether the Iron and Steel Control Equalisation Fund transactions are passed through the Consolidated Fund of India; and
 - (b) if not, what are the reasons therefore?

THE MINISTER FOR HEAVY IN-DUSTRIES (SHRI M. M. SHAH): (a) and (b). At the time, when the Equalisation Fund was constituted in February 1943 there was no Consolidated Fund of India. When the Consolidated

Fund of India was introduced in 1951, the future of the Equalisation Fund was uncertain. It has since been decided to continue the Fund on a permanent basis, and action has been initiated to pass its transactions through the Consolidated Fund of India.
