SHRI V . K. DHAGE: I think the microphones on that side are not functioning.

KRISHNAMACHARI: The question related to the import of looms price etc. and I said that looms were allowed to be imported for the purpose of replacement in the ordinary course by asking for permission to import. We have not got the information ready at hand nor do we ask for all these when we grant licences for import.
