- *425. SHRI V. S. SARWATE: Will the Minister for Home Affairs be pleased to state:
- (a) the number of applications received for the Indian Administrative Service Special Recruitment Examination up to the end of July 1956; and
- (b) the date fixed for the examina-

THE MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. DATAR): (a) The total number of applications received up to the 31st July 1956 is 22,896.

- (b) No date has so far been fixed for the examination; but it is likely to be held some time in December 1956.
- PROF. G. RANGA: What is the number of the candidates whom Government wish to recruit or appoint?
- Shri B. N. DATAR: About 125, I have already told this House, 125 through direct recruitment.
- DR. P. C. MITRA: What was the total amount of fees received from the candidates with their applications?
- SHRI B. N. DATAR: That would become clear to the hon. Member by simply multiplying 22,896 by, I believe about Rs. 35. In the case of Scheduled Castes it is a little less.
- DR. P. C. MITRA: May I know whether any sum will be refunded to the unsuccessful candidates?
- Shri B. N. DATAR: Sir, ordinarily no sum would be refunded except in one case, where previous intimation is given, and there also a fraction is refunded.

SHRIMATI MAYA DEVI CHETTRY: May I know, Sir, whether there is any lady candidate in this?

SHRI B. N. DATAR: I am quite certain, Sir, that at least there would be 100 applicants.

SHRI MAHESH SARAN: Are all Government servants who have the requisite qualifications permitted to apply for this?

SHRI B. N. DATAR: Yes, Sir.

SHRI MAHESH SARAN: Is the hon. Minister aware that the Railway Department has not been permitting its employees to apply for the I.A.S. Special Recruitment Examination?

SHRI B. N. DATAR: We have issued general circulars that if any Government servant in that department is anxious to appear and is otherwise eligible, ordinarily he should be allowed and there is some discretion left with the heads of these offices.

SHRI MAHESH SARAN: Am I to understand that those people who have applied and whose applications have not yet been forwarded will get fresh time to apply?

SHRI B. N. DATAR: How can they get fresh time? Their applications have to go through the heads of their offices.

SHRI P. N. SAPRU: Am I correct in inferring from the Home Minister's reply that while there would be no discrimination on the ground of sex there would be no preference shown to any member of any particular sex?

SHRI B. N. DATAR: May I point out that under the Constitution it is there?
