REVIEWING COMMITTEES FOR MUSEUMS

*7. **SHRI M. GOVINDA REDDY:** Will the Minister for EDUCATION be pleased to state:

(a) whether Reviewing Committees have been appointed for any of the museums in India; and

(b) if so, what are the particulars thereof?

THE DEPUTY MINISTER FOR EDUCATION (DR. MONO MOHAN DAS): (a) and (b). A Reviewing Committee has been appointed for the Indian Museum, Calcutta. An Expert Museums Survey Committee has also been appointed by Government.

SHRI M. GOVINDA REDDY: May I know, Sir, whether there is a proposal to appoint a Reviewing Committee for other museums?

DR. MONO MOHAN DAS: Sir, the Expert Museums Survey Committee has been appointed by the Government for all the museums in India.

SHRI M. GOVINDA REDDY: May I know, Sir, whether the question of reorganising all museums is before this Reviewing Committee?

DR. MONO MOHAN DAS: Sir, the Expert Museums Survey Committee has been appointed to survey the needs of the museums in India, and to make concrete proposals for their improvement and development.

INQUIRY INTO THE WORKING OF DALMIA-JAIN CONCERNS

*8. **SHRI M. GOVINDA REDDY:** Will the Minister for FINANCE be pleased to state:

(a) whether there is a proposal to set up a Commission to inquire into the working of the Dalmia-Jain concerns;

(b) if so, what are the terms of reference to the Commission; and

(c) what is the basis of selection of its personnel?

THE MINISTER FOR REVENUE AND CIVIL EXPENDITURE (SHRI M. C. SHAH): (a) to (c). Yes, Sir. The matter is still under consideration.

SHRI M. GOVINDA REDDY: May I know, Sir, how long it will take the Government to come to a decision in this matter?

SHRI M. C. SHAH: Not long.

SHRI M. GOVINDA REDDY: May I know whether the appointment of the Commission is under consideration, as also the question of selecting personnel for the Commission?

SHRI M. C. SHAH: I say that the proposal is there, and when that proposal is accepted, there will be terms of reference, and then there will be the question of appointing the necessary personnel, and all that.

SHRI M. GOVINDA REDDY: May I know, Sir, how many concerns come within the purview of this Commission?

SHRI M. C. SHAH: I am afraid I cannot disclose all these matters at the present stage.

SHRI M. GOVINDA REDDY: May I know, Sir, whether the present investigation that is going on will stop, if this Commission is appointed, or it will go on independently of the Commission?

SHRI M. C. SHAH: Which investigation? If the hon. Member refers to the Bharat Insurance Company, where Rs. 2,20,00,000 were found missing and Shri Ramkrishna Dalmia was arrested, that investigation is going on, and that will go on, and that investigation will be completed very shortly.

SHRI S. N. MAZUMDAR: On a previous occasion, Sir, the hon. Minister had said that the affairs of all the Dalmia-Jain concerns were being investigated into. So, am I to understand that this was kept outside the purview of that investigation, or in the course of the investigations something special has occurred for an enquiry into this matter? What is the actual position?
