SHRI M. C. SHAH: Perhaps there is some misunderstanding on the part of the hon. Member. Here, the questioner is asking about the Dalmia-Jain concerns, whereas the investigation is with regard to the Bharat Insurance Company's funds found missing.

SHRI S. N. MAZUMDAR: May I just remind the hon. Minister that in answer to a question of mine regarding the representation by the Times of India employees in Bombay, the answer given to me was that the investigations were in respect of all the concerns of this particular gentleman?

SHRI M. C. SHAH: Well, I do not remember having replied that way. His .memory is not correct.

SHRI M. GOVINDA REDDY: May I know whether this Commission will be appointed after the investigation with regard to the Bharat Insurance Company concludes, or whether it has no relation to the investigation that has been going on now?

SHRI M. C. SHAH: There is no relation between this proposal for appointing a Commission of Enquiry and the investigation being held with regard to the Bharat Insurance Company. It is a case which is being investigated by the Special Police Establishment. The misappropriation was to the extent of Rs. 220 lakhs. Those monies have already been recovered, as the House knows, after the Ordinance was promulgated, attaching the properties of all those connected with such things. Now, that enquiry is with regard to the criminal case to be launched against Shri Ram-krishna Dalmia, and that investigation is going on under the Home Ministry's Special Police Establishment, and it is nearing completion.

RATANLAL **KISHORILAL** MALVIYA: May I know, Sir, what is being done in other cases of a similar nature? For instance, there was a gentleman from Vindhya Pradesh who went underground when the insurance business was nationalised; What has happened in such cases?

SHRI M. C. SHAH: If any cases are specifically mentioned, I will be in a position to reply.

- SHRI H. C. DASAPPA: What is the anticipated amount of oil that you can find there?
- SHRI K. D. MALAVIYA: Much more work has to be done. So, no final figures can be quoted, but the investigations so far carried out go to indicate that perhaps more than one million tons of oil can be obtained every year.
