THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI T. T. KRISHNA-MACHARI): (a) About Rs. 32 lakhs worth of cork products (including insulation corks). Information in terms of quantity is not available.

- (b) About Rs. 18 lakhs worth,.
- (c) By imports.

PLANT FOR PRODUCTION OF SYNTHETIC OIL

- 221. SHRI M. VALIULLA: Will the Minister for PRODUCTION be pleased to state:
- (a) what progress has been made towards setting up the proposed Synthetic Petroleum Plant in the country;
- (b) who are the consultants for this project; and
- (c) how long it will take to com mence production of this petrol?

THE MINISTER FOR PRODUCTION (SHRI K. C. REDDY): (a) The experts Committee on Synthetic Oil Project have submitted their report, which is under examination. No final decision in the matter has yet been taken by Government.

- (b) Consultants are not yet chosen, that will be done only when a decision is taken to take up the Project.
- (c) At this stage it is not possible to give an answer.
