SHRI O. V. ALAGESAN: Naturally Government would like the process to be faster, but Government has also to take into consideration the size of its purse.

Oral Answers

DR. W. S. BARLINGAY: Since the answer to part (c) is "No", may we know whether the Third Five Year Plan at least will be able to fulfil the target?

Shri O. V. ALAGESAN: Yes, in the Third Plan we hope to reach the targeted tonnage of 2 million tons.

SHRI M. VALIULLA: We are told that at present our shipping is only half per cent of the world shipping tonnage. At the end of the Second Plan, what will be our percentage, if all goes well?

Shri O. V. ALAGESAN: I have said that our tonnage will be raised from 6 lakh tons at the end of the First Plan to 9 lakh tons, that is an increase of 50 per cent in the tonnage. What proportion that will bear to the world tonnage will depend on the size of the world tonnage at that time.

## CONSTRUCTION OF THE RAILWAY STATION AT ANAKAPALLI

\*452. SHRI V. VENKATA-RAMANA: Will the Minister for RAILWAYS be pleased to state:

- (a) what is the estimated cost of the Railway Station which has been constructed at Anakapalli; and
- (b) when sanction for its construction was given?

THE DEPUTY MINISTER FOR RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) Presumably the Hon'ble member is referring to the remodelling of Anakapalli Railway station, the estimated cost of which is Rs. 3,05,100.

## (b) On 18th September 1951.

SHRI V. VENKATARAMANA: Does it include the construction of the over-bridge there?

SHRI O. V. ALAGESAN: No, Sir. This does not include the construction of the overbridge. This relates to the remodelling of the station, platform sheds, etc.
