SHRI H. C. DASAPPA: May I know which is the body constituted for such a survey?

SHRI N. KANUNGO: The Ministry itself with the help of the Develorment. Wing.

SHRI H. C. DASAPPA: May I know as to whether the Ministry itself goes round the country surveying the various scarce materials or whether it does it through some particular agency?

SHRI N. KANUNGO: The Development Wing, I said.

SHRI M. GOVINDA REDDY: What steps have been taken for the development of these raw materials?

SHRI N. KANUNGO: So far as coal, cement and iron and steel are concerned, the steps taken have been mentioned in this House, and if notice is given, the steps will be mentioned again.

SHRI MAHESWAR NAIK: In view of the fact that iron and steel constitute scarce materials, does the Government propose to stop their export of iron ores?

SHRI N. KANUNGO: That will not solve the problem. The problem will be solved only if we manufacture enough iron and steel.

SHRI H. C. DASAPPA: May I know whether, apart from pig iron, steel and coal, there are no other scarce materials in the country?

SHRI N. KANUNGO: There are other items but they are not controlled. And they are not of such important significance.

†MANUFACTURE OF CANE-CRUSHERS WITH BIGGER ROLLERS AT NAHAN FOUNDRY LTD.

*35. Dr. RAGHUBIR SINH BEHALF OF MOULANA M. FARUQI): Will Minister for COMMERCE AND INDUSTRY be pleased to refer to the

answer given to Unstarred Question No. 182 in the Rajya Sabha on the 1st March 1956, and state the reasons for the decision of not undertaking at present the manufacture of canecrushers with bigger rollers at the Nahan Foundry Ltd.?

THE MINISTER FOR INDUSTRIAL DEVELOPMENT (SHRI M. M. SHAH): The manufacture of cane-crushers with bigger rollers has not been pursued so far for the following reasons:

- (a) Though the bigger rollers would have a higher crushing capacity, their efficiency in the matter of juice extraction would lower:
- (b) Rollers of bigger diameter might prove too heavy for the bullocks; and
- (c) The manufacture of bigger rollers would involve the preparation of fresh moulds for all the components of the cane-crushers and would call for fresh capital investment as well as a great deal of technical work and supervision.

These points are being studied as a part of the proposals to reorganise the production programme of the foundry on more economic lines, and if found profitable, the foundry will undertake such manufacture.

DR. RAGHUBIR SINH: How much time do they expect to take?

SHRI M. M. SHAH: I am going myself next week to the factory. I hope that the reorganisation programme will not take more than a month.

SHRI KISHEN CHAND: In view of the fact that several new sugarcane factories are being set up in country, will it not be better to manufacture the big rollers in the Nahan factory rather than import them from foreign countries?

SHRI M. M. SHAH: It is really more for cottage industry and not for the big sugar factories. It is a question of balance between the small rollers and the big rollers. While the big rollers have got more capacity, the small rollers are more economical, since the efficiency of juice extraction in the case of the big rollers is lower than in the case of the small rollers.
