

know whether all the laboratories and workshops provided for in these technical institutions are being kept fully engaged throughout the day?

DR. MONO MOHAN DAS: I would like the hon. Member to realise that we are building up many of our technological institutes, and it may be that for the time being, there are not adequate facilities—I mean equipment and other things. So, there may not be adequate number of students.

SHRI JASWANT SINGH: What is the number of these technical institutions, and where are they situated?

DR. MONO MOHAN DAS: It is difficult to give off hand the total number of technical institutions in this country. But so far as the Education Ministry in the Government of India are concerned, there are only two—the Indian Institute of Technology at Kharagpur and the Delhi Polytechnic. There are others which will spring up very soon.

#### COLLEGES OF PHYSICAL EDUCATION

\*169. DR. RAGHUBIR SINH (ON BEHALF OF MOULANA M. FARUQI): Will the Minister for EDUCATION be pleased to state:

(a) the names of the various colleges of Physical Education which are aided by the Central Government;

(b) whether any research is being conducted in the field of Physical Education in these colleges; and

(c) whether any special grant has been sanctioned by Government for the purpose referred to in part (b) above?

THE DEPUTY MINISTER FOR EDUCATION (DR. K. L. SHRIMALI): (a) No regular grant-in-aid is paid to any college of physical education. Grants of non-recurring nature only are paid on an *ad hoc* basis.

(b) No information is available with the Government.

(c) No, Sir.

DR. RAGHUBIR SINH: May I know to whom the non-recurring grants have been given?

DR. K. L. SHRIMALI: During the year 1955-56, we have given to the institutions which I am naming:

DR. RAGHUBIR SINH: May I know if there are any applications which have not been accepted?

DR. K. L. SHRIMALI: I shall need notice with regard to that question. There is one application which is pending from the Punjab Government.

SHRI JASWANT SINGH: May I know if the Government proposes to set up any college for physical training?

DR. K. L. SHRIMALI: Yes, Sir. The Government proposes to set up a National Physical College.

SHRI JASWANT SINGH: May I know where it will be located?

DR. K. L. SHRIMALI: It is going to be set up at Bhopal.

SHRI KISHEN CHAND: Is the hon. Minister aware that there are tests for physical standards in Europe, U.S.A. and U.K.? Is there any research going on in our country for setting up standards in physical education?

DR. K. L. SHRIMALI: I am not aware of it, but the Advisory Board did make certain recommendations to the physical education colleges. I am not aware whether research has also been included. Anyway, the college that we propose to set up will also conduct research.

**डा० के० एल० श्रीमाली :** मैं हर एक जगह के बारे में तो नहीं बता सकता। इसके लिये नोटिस चाहिये।

**DR. W. S. BARLINGAY:** What is the basis of the grant given to the Hanuman Vyayam Prasara Mandal of Amraoti? The amount appears to be very paltry.

**DR. K. L. SHRIMALI:** Well, Sir, the basis of the grant is that the physical education institution should have 40 per cent, reserved for students from other States. Grants are paid to the institution for undertaking an approved research subject of all-India importance, and grants are paid up to 50 per cent, for non-recurring expenditure, provided that the application is made by the institution or the State Government concerned. No recurring grant is paid to any institution. These are some of the conditions under which grants are paid. The applications from each individual institution are examined and grants are given on merit.

**DR. W. S. BARLINGAY:** Will it not be possible to increase the grant?

**DR. K. L. SHRIMALI:** With regard to this, that is the question for the Central Advisory Board.

#### DEVELOPMENT OF AUXILIARY CADET CORPS

♦170. **DR. RAGHUBIR SINH** (ON BEHALF OF MOULANA M. FARUQI) : Will the Minister for DEFENCE be pleased to state:

(a) whether a scheme for the development of Auxiliary Cadet Corps has been included in the Second Five Year Plan;

(b) if so, what are the broad outlines of this scheme; and

(c) what amount has been set apart under the Second Five Year Plan for this scheme?

**THE MINISTER FOR DEFENCE ORGANISATION (SHRI MAHAVIR TYAGI) :**

(a) Yes, a programme of expansion has been approved for the Plan Period.

(b) It is proposed to increase the strength of A.C.C. by about 1-5 lakhs per year.

(c) The cost of this expansion would be about Rs. 8 crores for the Plan period.

**SHRI GOPIKRISHNA VIJAIVAR-GIYA:** What will be the total number then?

**SHRI MAHAVIR TYAGI:** One lakh and fifty thousand per year for five years.

**SHRI GOPIKRISHNA VIJAIVAR-GIYA:** Does that include the present strength?

**SHRI MAHAVIR TYAGI:** The present strength is about 5,78,000 as on the 1st January last.
