refrain from excessive public consumption of liquor, as it offends public sentiment. Liquor is not served at official private functions when non-Service personnel are present in Service messes in those States where prohibition is already in force. The Medical Service Advisory Committee proposes to set up a team to study the effects of alcohol at low temperatures and high altitudes with a view to examining whether Service personnel serving cold climates should continue to be issued with alcoholic drinks as part of their rations. I may add that the Defence Ministry, Army Headquarters and other Service have agreed to abide by Headquarters whatever recommendations are made by the Prohibition Committee or the Government with regard to prohibition in the country.

DR. RAGHUBIR SINH: May I know whether there have been cases, which have come to the notice of the Commanding Officers, where the instructions given in respect of drinks as given by the hon. Minister to the House were not fully complied with, and, if so, whut action was taken in respect of those cases?

SHRI MAHAVIR TYAGI: I have no ready information, but wherever any orders are not complied with, immediate action is always taken in the Army. I may assure the House that the consumption of liquor has gone down far beyond expectations in the Army, the Navy and the Air Force.

DR. RAGHUBIR SINH: I know that Immediate action is taken in the Army. I was wanting to know what type of action is taken. Obviously, this is not a case in which the man can be charged and tried.

SHRI MAHAVIR TYAGI: I remember that on some file I saw disciplinary action being taken when it was found that the bill for liquor was very high. Action is always taken

DR. RAGHUBIR SINH: Was it ascertained that the liquor consumed by others?

SHRI MAHAVIR TYAGI: Before a report is made, they ascertain that ihe man drank too much.

SHRI MAHESWAR NAIK: Is that not a hypothetical question?

श्रीमती सावित्री निगम: क्या मैं जान सकती हूं कि जो प्रोहिबिशनरी कमेटी बनाई गई, वह कितने दिनों में ग्रपनी रिपोर्ट सबिमट कर देंगी?

श्री महावीर त्यामी: मेरी इस बारे में श्रानरेबिल मेम्बर से प्राइवेटली बात हुई थी श्रीर मैंने वादा किया था कि मैं उनकी मदद करूंगा।

श्रीमती सावित्री निगम: श्रीमत्, मेरे सवाल का मतलब उस कमेटी से था जों फोर्सेंज में यह देखने के लिये मुक्कर्रर को गई है कि शराब का सेना में कितना कंजम्शन है, वह किस जगह होना चाहिये और किस जगह कम होना चाहिये। इस काम के लिये जो सर्वे कमेटी बनाई गई थी, वह अपनी रिपोर्ट कब तक सबमिट करने वाली है ?

श्री महाबीर त्यागी: मैंने ग्रजं किया कि एक कमेटी डाक्टर लोगों की इस बात को देखने के लिये बनाई गई है कि ठंडो या बफों लो जगहों में जो रम सिपाहियों को दी जाती है उससे उनको फायदा होता है या नुकसान होता है ? इस रिपोर्ट का मैंने जिक किया था।
