Shri B. M. GUPTE: Has the Ministry informed other Ministries of the decision of the Government and asked them to implement it?

Dr. K. L. SHRIMALI: Yes; all the Ministries and all the State Governments have been informed.

SHRI B. M. GUPTE: What steps are the Ministries taking?

Dr. K. L. SHRIMALI: We have made a reference to the Ministry of Works, Housing and Supply, and requested them to bring the reformed script to the notice of the Controller of Printing and Stationery and other printing presses. They have referred the matter to the Controller of Printing and Stationery who has informed us that the matter is under their active consideration. They have also invited comments from Messrs. Linotype & Machinery Ltd., Messrs. Eastern Monotype Corporation Ltd., Calcutta. The Government are making every effort to expedite the matter.

DR. RAGHUBIR SINH: May I know, if this reformed script is going to be used in relation to the Sanskrit publications also?

Dr. K. L. SHRIMALI: For all Devanagari publications.

Dr. RAGHUBIR SINH: Have the Marathi linguists accepted it?

DR. K. L. SHRIMALI: I am at present referring to Devanagari script, and this is the decision taken with regard to Devanagari script. I do not know what the Marathi people have accepted.

SHRI H. C. DASAPPA: May I point out to the hon, Deputy Minister, that the printing the spelling is full of mistakes? I find here under C-"Nautical & Engubeering College". I take it that it is Engineering. And likewise, there are so many other mistakes in the statement, and I will make a suggestion that the matter may be more carefully looked into. Sometimes, it becomes difficult to understand these things. May I know whether these scholarships and fellowships are shown here are granted by the Central Government, or the State like to ask another question. May I

Government, or by any other institu-

Dr. MONO MOHAN DAS: scholarships that have been shown here are granted by the Central Gov-ernment, the State Government. and other private organisations.

SHRI S. MAHANTY: May I know whether all the training facilities in all these technical institutions are being fully utilised?

Mr. CHAIRMAN: Whether the training facilities in all these institutions are fully utilised—he asks.

DR. MONO MOHAN DAS: Sir, if the hon. Member means by 'fully utilised' whether all these scholarships are utilised or not, I should say that they are utilised.

SHRI S. MAHANTY: The question is: "how many students are at present studying in the Central Government institutions which impart technical education?" My question is, in view of the great deficiency of technical manpower in this country, whether all the training facilities in these technical institutions are being fully utilised or not?

DR. MONO MOHAN DAS: Yes, Sir. They are being utilised.

SHRI S. MAHANTY: From the statement, it appears that in a number of instances, the facilities are not being fully utilised. May we know what is the reason for that?

DR. MONO MOHAN DAS: In the statement, is there anything which shows that the facilities are not utilised?

SHRI S. MAHANTY: I have not the statement with me, but I would like to have the answer from the hon. Minister.
