*185. SHRI B. M. GUPTE: Will the Minister for EDUCATION be pleased to state:

(a) whether Governmeat have accepted the recommendations of the Devanagari Script Reform Conference held at Lucknow in November, 1953 under the Chairmanship of Dr. S. Radhakrishnan; and

(b) if so, what is the reason for not giving effect to this decision in their later publications *e.g.*, Scientific Terminology Series Booklet No. 185?

THE DEPUTY MINISTER FOR EDU-CATION (DR. K. L. SHRIMALI): (a) Yes, Sir.

(b) Publication can be brought out. in the reformed script 6nly wher! printing presses are suitably equipped* for the purpose.

DR. K. L. SHRIMALI: Yes; all the Ministries and all the State Governments have been informed.

SHRI B. M. GUPTE: What steps are the Ministries taking?

DR. K. L. SHRIMALI: We have made a reference to the Ministry of Works, Housing and Supply, and requested them to bring the reformed script to the notice of the Controller of Printing and Stationery and other printing presses. They have referred the matter to the Controller of Printing and Stationery who has informed us that the matter is under their active consideration. They have also invited comments from Messrs. Linotype & Machinery Ltd., and Messrs. Eastern Monotype Corporation Ltd., Calcutta. The Government are making every effort to expedite the matter.

DR. RAGHUBIR SINH: May I know, if this reformed script is going to be used in relation to the Sanskrit publications also?

DR. K. L. SHRIMALI: For all Devanagari publications.

DR. RAGHUBIR SINH: Have the Marathi linguists accepted it?

DR. K. L. SHRIMALI: I am at present referring to Devanagari script, and this is the decision taken with regard to Devanagari script. I do not know what the Marathi people have accepted.
