THE MINISTER* FOR FINANCE (SHRI C. D. DESHMUKH): (a) The rate of exchange between the Indian and Nepalese currencies has been fluctuating from time to time. During the last week it oscillated between Rs. 150 to Rs. 164 Nepalese to Rs. 100 Indian.

t [DISPLACED GOVERNMENT SERVANTS RETAINED IN SERVICE AFTER SUPERANNUATION

153. SHRI NAWAB SINGH CHAUHAN: Will the Minister for HOME AFFAIRS be pleased to state:

(a) the present number of displaced permanent Government servants who are being retained in service after their reaching the age of superannuation; and

(b) the exact period for which they can be retained in service?]

मंत्री गृहकार्य मंत्रालय (श्री बी० एन० दातार) : (क) श्रेणी I अथवा II के ग्यारह नान टैक्नीकल विस्थापित स्थायी सरकारी कर्मचारी निवृत्ति आयु के बाद भी नौकरी कर रहे हैं। टैक्नीकल अथवा श्रेणी III तथा IV के कर्मचारियों की सूचना अभी तैयार नहीं है।

(ख) अवधि समय समय पर निर्धारित की जाती है और आम तौर पर यह ध्यान रखा जाता है कि उनके पेंशन के मामलों के तय होने का समय इस में आ जाए।

[THE MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. DATAR) : (a) Eleven displaced permanent Government servants holding non-technical class I or class II posts are continuing in service beyond the age of superannuation. Information is not readily available regarding technical personnel or class III and class IV employees.

(b) The period is determined from time to time, and is generally intended to cover the time required for finalising their pension cases.]
