DR. RAGHUBIR SINH: May I know if the information is correct that in many cases, big grants were given just in the last months of the Five Year Plan?

DR. K. L. SHRIMALI: So many schemes are sanctioned and it is very difficult to answer that question off-"hand. But it is true that some schemes are sanctioned late In the year also.

SHRIMATI SAVITRY DEVI NIGAM: May I know the number of schools which have been converted from ordinary schools and the number of schools which have been started anew and which have been given grants by the Central Government?

DR. K. L. SHRIMALI: I am afraid I shall need notice to answer that question.

Dr. K. L. SHRIMALI: Does the hon. Member want to know the basis era which we are giving grants?

DR. RAGHUBIR SINH: Yes.

DR. K. L. SHRIMALI: Under scheme No. 1, that is, for the reconstruction of secondary education, Central assistance was given at the rate of 66 per cent, of the total nonrecurring expenditure and 25 per cent, of the recurring expenditure. Under scheme No. 2, that is, improvement of selected secondary schools, Central assistance was calculated at the rate of 66 per cent. of nonrecurring expenditure and one-third of recurring expenditure.

SHRI H. C. DASAPPA: How is it that some States get disproportionately low grants while others get fairly reasonable grants?

DR. K. L. SHRIMALI: It all depends upon the nature of the proposals we receive from the State Governments.

DR. RAGHUBIR SINH: May I know whether this formula was adhered to in respect of Part C States?

DR. K. L. SHRIMALI: I think, Sir, that the Government gives some subsidy to Part C States also.

DR. RAGHUBIR SINH: In this statement I find that Bhopal has got more than Hyderabad. Orissa and U.P. practically get the same.

DR. K. L. SHRIMALI: We did not get proper proposals from U.P. We have surrendered some moneyl also. We invite proposals from the State Governments and grants are sanctioned on the basis of the proposals that are approved by the Central Government.

Dr. RAGHUBIR SINH: May I know if any proposals were received which were not accepted by the Central Government?

DR. K. L. SHRIMALI: This relates to all over India and it wijll be difficult to give this information offhand.

SHRI B. B. SHARMA: What is the nature of the improvement for which the amount is spent?

DR. K. L. SHRIMALI: Nature of improvement? They are converting the high schools into multi-purpose schools. Then we are introducing various kinds of coursessicience courses, technical courses, .agricultural courses, improvement of library and so on.
