SHRI M. VALIULLA: What has been done to implement this agreement regarding transfer of movable property from one country to another? Has any implementation commission been formed? If so, how many times has it met and what has been done so far?

SHRI J. K. BHONSLE: There have been a number of meetings since 1950 and I might say that by the March 1955 agreement things have been finalised in such a manner that all movable property can be moved from both the countries.

DR. P. C. MITRA: What is the value of such property?

SHRI J. K. BHONSLE: It is very difficult to give that figure at this stage.

#### EXPORT PROGRAMME OF CAR- ASSEMBLING UNITS...

\*309. SHRI M. VALIULLA: Will the Minister for COMMERCE AND INDUSTRY be pleased to state:

(a) whether any export programme has been submitted to Government by the car-assembling and car-producing units in India; and

(b) if so, whether these units have been permitted to export cars?

THE MINISTER FOR INDUSTRIAL DEVELOPMENT (SHRI M. M. SHAH) : <a> No, Sir.

l(b.) Does not arise.

SHRI M. VALIULLA: What will be the output of cars at the end of the second Five Year Plan; what will be the consumption capacity by that period and, if there will be any surplus, what is it that the Government wants to do for that?

SHRI M. M. SHAH: The present capacity is 23,084 annually and the projected annual capacity at the end of the second Five Year Plan is 42,000. Government is taking all steps to increase licensed production and also to establish new concerns.

SHRI M. VALIULLA: My question was: What will be the consumption capacity by the end of second Five Year Plan? The hon. Minister has been kind enough to give the production capacity, which is put at 42,000. I want to know the consumption capacity, and if there is any surplus, the steps that Government would take in that regard.

SHRI M. M. SHAH: I said that the projected capacity, which is equated to consumption, would be about 42,000 cars a year. There will be hardly any exportable surplus but even so, Government is trying to have some token exports.
