

STRIKE IN BHILAI STEEL PLANT

*371. SHRI S. PANIGRAHI: Will the Minister for IRON AND STEEL be pleased to state:

(a) whether there was a strike in the Bhilai Steel Plant by the workers of the Plant recently; and

(b) if so, the reasons of the strike and the steps taken to remove the difficulties, if any, of the workers?

THE MINISTER FOR COMMERCE AND INDUSTRY AND IRON AND STEEL (SHRI T. T. KRISHNAMACHARI) : (a) No Sir.

(b) Does not arise.

IMPORT* AND EXPORT^ OF BETEL-NUTS BETWEEN STATES IN INDIA

197. SHRI M. VALIULLA: Will the Minister for COMMERCE AND INDUSTRY be pleased to state:

(a) the names of the States which import betel-nuts from other States in India;

(b) which are the importing States and which are the exporting States; and

(c) whether any licence is required for exporting and importing betel-nuts?

THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI T. T. KRISHNAMACHARI) :

(a) The States that import betel-nuts from other States in India are as follows:—

Assam, Bihar, Bombay, Madhya Pradesh, Orissa, Punjab, Uttar Pradesh, Hyderabad, Jammu and Kashmir, Mysore, PEPSU, Rajasthan, Saurashtra, Travancore-Cochin, Andaman, Ajmer, Bhopal Coorg, Delhi, Kutch, Manipur, Tripura, Vindhya Pradesh and Pondicherry.

(b) The States which export betel-nuts to other States in India are as follows:—

Bombay, Madras, West Bengal, Mysore, Travancore-Cochin and Coorg.

(c) No import or export licence is required for the movement of betel-nuts from one State to another in the Indian Union.

IRON SMELTING

198. SHRI MAHESWAR NAIK: Will the Minister for COMMERCE AND INDUSTRY be pleased to state:

(a) whether iron smelting is the concern exclusively of the factory industries or any part of it has been set apart for the cottage industries; and

(b) to what extent the low grade iron-ores, as are not required for export, are being utilised by the large-scale iron and steel industries?

THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI T. T. KRISHNAMACHARI) :

(a) Mostly iron smelting is done only by large-scale factories. It is not economical to smelt iron-ore on a cottage industry basis.

(b) Low grade iron-ores are not generally being used by large-scale iron and steel industries.

LOANS GIVEN FOR BHAKRA NANGAL PROJECT

(a) the amount of loan so far given towards the construction of the Bhakra-Nangal Project;
