SHRI GULZARILAL NANDA: I may explain that in working out our calculations for the Second Five Year Plan, we take the figures of employment achieved at the end of the First Five Year Plan. This has two aspects, continuing employment and employment in activities like construction, but similar construction programmes are continuing in the Second Year Plan. Therefore, the additional employment indicated in the Second Five Year Plan is at a higher level, because of a higher level of construction activity. They may not be the same projects. There are other projects which absorb a larger number.

SHRI MAHESWAR NAIK: Has the Government any idea whatever as to the extent of reduction in unemployment at the end of the Second Five Year Plan?

Mr. CHAIRMAN: It is indicated in the Plan itself.

SHRI DEOKINANDAN NARAYAN: In the First Five Year Plan something like two million are shown as engaged in construction, and when that construction work is over, what happen to these two million?

Mr. CHAIRMAN: Other projects will be undertaken and they will be re-employed.

FILMS PRODUCED EXCLUSIVELY FOR CHILDREN
