required. I would .like to know exactly from the hon. Member as to whether he wants the foreign debt of the country—in that case I - have replied—or if he wants the debt of the Central Government of India and of the Part A and B States.

SHRI MAHESWAR NAIK: My intention was to get information about internal indebtedness; not the foreign debt.

Mr. CHAIRMAN: His question related to internal indebtedness and not foreign debt, he says.

SHRI M. C. SHAH: Internal indebtedness means the indebtedness of the Central and the State Governments and of all the people at large?

MR. CHAIRMAN: The Governments'— Central and State.

SHRI M. C. SHAH: Excluding the public debt of Part B States the outstandings on 31st March 1951 are not readily available. The rupee debt, that is, the outstanding loans inside India of the Centre and Part A States increased from Rs. 1497 crores on 31st March 1951 to Rs. 1686 crores on 31st March 1956, that is, an increase of Rs. 189 crores. The outstanding public loans of Part B States on 31st March 1956 amounted to Rs. 81 crores.

DIWAN CH AM AN LALL: How ! much of this sum of Rs. 189 crores, excluding Part B States, was utilised for productive purposes?

SHRI M. C. SHAH: I have not got that break-up. I can only say that these are the outstanding loans of the Centre and Part A States. If there is a separate question on that point, I will enquire.

ALL-INDIA TRIBAL CONFERENCE

*390. SHRIMATI SAVITRY DEVI NIGAM: Will the Minister for Home Affairs be pleased to. state:

(a) whether Government propose to hold an All-India Tribal Conference in the near future; and (b) the date and year when such a conference was'held last time?

THE MINISTER FOR HOME AFFA IRS (SHRI GOVIND BALLABH PANT); (a) There is no such proposal.

श्रीं गोविन्द बल्लभ पंत: सन् १६५२ में जो कांफ्रेंस हुई थी उसका हाल उस वका शेड्यूल्ड कास्ट किसश्नर ने जो रिपोर्ट दी शी उसमें दिया हुआ है और वह रिपोर्ट मेम्बरों को भेजी गई थी। उस पर कितनी कार्यवाही हुई उसका भो ब्यौरा उस रिपोर्ट म दिया हुआ है। उम्मीद को जाती है कि मानतीय सदस्या उन सब रिपोर्टों को गौर से देखेंगी।

SHRI V. PRASAD RAO: May I know, who are all invited to this conference and what is the criterion for extending the invitations to these people.

SHRI GOVIND BALLABH PANT: i I have not been able to follow the question.

Oral Answers

MR. CHAIRMAN: Who are all invited to this conference and how are the selections made? That is the question.

SHRI GOVIND BALLABH PANT: In order to get over all these embar-rasing questions, we are not holding any conference hereafter.

SHRI V. PRASAD RAO: Sir, I could not follow.

MR. CHAIRMAN: The last conference was held in 1952 and the Home Minister says that he does not propose to hold any conference hereafter.

THE MINISTER FOR HOME AFFAIRS (SHRI GOVIND BALLABH PANT): (a) No.

(b) Does not arise.

SHRI PERATH NARAYANAN NAIR: May I know, Sir, if any officer was deputed either by the Central Government or at the instance of the Central Government and has he made any report?

SHRI GOVIND BALLABH PANT: This incident happened about five or six years ago. Many enquiries were held and the Travancore-Cochin Government deputed one of, its own Deputy Inspectors General to investigate the matter and look into it carefully. After considering everything

they came to the conclusion that no action could be taken against anyone.

SHRI PERATH NARAYANAN NAIR: Is the Government aware that three is a strong public feeling in the State that this burning of the temple was part of a move to incite communal feeling and that prominent personalities were involved in that?

SHRI GOVIND BALLABH PANT: I hope that all will combine together to get over that communal feeling now that more than five years have passed and public interest requires that men should apply their minds to constructive work and not harbour such feelings any longer.

SHRI PERATH NARAYANAN NAIR: The feeiing persists now, because certain personalities are shielded. Is the Government aware of that?

SHRI GOVIND BALLABH PANT: I have not followed the question.

MR. CHAIRMAN: The feeling persists because certain personalities are shieldedthat is what he says.

SHRI GOVIND BALLABH PANT: Well, I am not aware of anyone being shielded.

SERVICE CONDITIONS OF TEACHERS IN TRAVANCORE-COCHIN
