eminent has received no letter from one or the other of these two companies?

SARDAR SWARAN SINGH: I do not understand as to why the hon. Member should feel that the only source of information is a letter. There are other ways of knowledge.

SHRI BHUPESH GUPTA: I know that there are many other sources. That is my fear also. Therefore, I ask which is that particular source from which he got that information?

SARDAR SWARAN SINGH: I have nothing to add to what I have already stated. The factual position is already fully stated. I do not think it necessary to disclose the source of that.

SHRI BHUPESH GUPTA: Do I understand that the source is something which cannot be disclosed on the floor of this House?

MR. CHAIRMAN: For the present, apparently.

DR. RAGHUBIR SINH: With reference to the statement placed on the Table of the House, I wanted to know what is item No. 5 described as "New Blooming Mill"?

SHRI N. KANUNGO: A mill which produces steel blooms.

DH. RAGHUBIR SINH: May I know. Sir, with whom these arrangements for expansion and supply of all this additional machinery have been arrived at by the Tatas?

SHRI N. KANUNGO: Tatas will buy their machinery from various sources. The consultants are Kaisers of U.S.A.

SHRI KISHEN CHAND: May I know from the hon. Minister whether the Government of India has given a 1197  $O^{1_{11}0_1}$  Answers

guarantee about that loan of Rs. 37 j crores to the Tatas?

SHRI N. KANUNGO: No, Sir.

DR. RADHA KUMUD MOOKERJI: May I know whether it is more economical to finance the expansion of existing iron and steel plants than to start a new one?

SHRI N. KANUNGO: That is a hypothetical question. Anyway we, are doing both expansion of existing plants as well as new plants.

DR. RADHA KUMUD MOOKERJI: The contention has been that it is more economical to finance the expansion of existing concerns than to incur a huge expenditure on starting new plants.

SHRI N. KANUNGO: Up to a point. A plant up to two million ton capacity is economical under present circumstances.

SHRI T. BODRA: May I know, Sir, if more lands will be required for this expansion?

SHRI N. KANUNGO: No, Sir.

SHRI BHUPESH GUPTA: May I know, Sir, if the Government has given any financial assistance for this expansion? If so, on what terms the assistance has been extended?

SHRI N. KANUNGO: A loan of Rs. 10 drores has been given to the Tata Iron and Steel Company on terms of bearing interest from the date of production.

SHRI BHUPESH GUPTA: May I know, Sir, whether before giving this financial assistance to the Tatas, the Government went into their internal finances in order to find out whether the Tatas could get their money from their own sources?

SHRI N. KANUNGO: Of course. They find the entire money from internal resources; they get from the market and their internal sources as well.
