DR. K. L. SHRIMALI: They have some statistics, but I do not know whether they are accurate statistics.

DR. RAGHUBIR SINH: Do Government propose to extend this facility to other big cities like Delhi?

Dr. K. L. SHRIMALI: Government have a scheme for developing a programme for all kinds of handicapped people, including the blind, in the next Five Year Plan.

SHRI M. VALIULLA: Sir, my previous question was not answered. I asked whether Government proposed to give this training to all the adult blind of our land.

DR. K. L. SHRIMALI: Sir, this is the one training centre started by the Government of India, and it is our intention to develop the programme. But it will not be possible to take full responsibility for all the adult blind immediately. However, a welfare State like ours must ultimately take the responsibility for all kinds of handicapped people.

SHRI M. VALIULLA: What are the rough statistical figures of the adult blind that the Government have got?

DR. K. L. SHRIMALI: I would require notice.

SHRI H. C. DASAPPA: What is the medium of instruction at this centre?

DR. K. L. SHRIMALI: They are adopting the Baraille method. As for giving the exact medium of instruction, I would require notice.

LOAN FROM THE WORLD BANK

*243. SHRI M. VALIULLA: Will the Minister for Finance be pleased to state:

- (a) whether Government are having negotiations with the World Bankfor any loan at present;
- (b) if so, what is the amount as and for; and
- (c) what is the purpose for which: the loan is to be taken?

THE DEPUTY MINISTER FOR FIN-ANCE (SHRI B. R. BHAGAT): (a) No-Sir.

(b) and (c). Do not arise.

SHRI M. VALIULLA: Is it not a fact that Government negotiated for a loan for the Industrial Credit and Investment Corporation?

SHRI B. R. BHAGAT: The World Bank has already agreed to finance this loan.

SHRI M. VALIULLA: Has that amount been drawn? What is the last date for the drawing of the loan amount?

SHRI B. R. BHAGAT: This loan has become effective only from December, 1955 and no drawal has yet taken place; it will take place very soon.

SHRI M. VALIULLA: I want to know the last date by which the loan has to be drawn. Also, there were negotiations going on for the Trombay Project. I want to know whether the amount in this respect has been drawn.

SHRI B. R. BHAGAT: These two loans have become effective only in December, 1955 and they could be drawn only after they become effective.

Shri M. VALIULLA: What is the last date for drawal? There is a last date by which the money has to be drawn, if not, some interest has to be paid.

Shri B. R. BHAGAT: I have not got information in that respect with me but I think that date has not yet expired.

SHRI B. C. GHOSE: For what purpose has the Government of India invited a Mission from the World Bank if no negotiation is intended to be undertaken?

SHRI B. R. BHAGAT: I could no. follow the question, Sir.

MR CHAIRMAN: The question is: "Why have you invited a Missio." from the World Bank if you have no intention of entering into any negotiation?"

SHRI B. R. BHAGAT: We have not said that we have no intention entering into any negotiation. The invitation for a Mission to come here is for a general survey of the economíc possibilities. After they submit 1 report, we will consider whether any negotiation should be started with the World Bank.

SHRI B. C. GHOSE: Do I understand that the Government has not approached the World Bank for any particular loan as yet?

Shri B. R. BHAGAT: No, Sir, not just now, but the previous loans are there. However, we may think of taking some loans and negotiations may start, but just now we are not having any negotiations.
