डा० के० एल० श्रीमाली : जी नहीं, फरमाइश का इस में कोई प्रश्न नहीं है जो स्कीम्स हैं उन को मिनिस्ट्री बनाती है। स्कीम्स के बनाने के बाद जो कुछ सहायता विदेश से हम को मिल सकती है उस सहायता को हम लेते हैं—हम उन से आर्थिक सहायता लेते हैं। फिर, जन सहायता भी जितनी मिल सके उस का भी हम पूरा उपयोग करना चाहते हैं। इस दृष्टि से उन वर्कशॉप्स को हम चला रहे हैं।

SHRI H. P. SAKSENA: What is the stuff manufactured in these educational workshops?

DR. K. L. SHRIMALI: The purpose of literary workshops is to bring together old literary persons who have already earned some reputation as authors and give them a short orientation course, so that they can write at the level of neo-literates or children, as the case may be. That is the main purpose why literary workshops have been organised. I have already explained that the purpose of secondary education workshop is to bring together teachers, headmasters and inspectors to discuss from a practical point of view some of the problems of secondary education.

DR. SHRIMATI SEETA PARMA-NAND: What is the financial liability of the Government in establishing these workshops?

DR. K. L. SHRIMALI: I shall need notice to answer that question,

STATEMENT

*Modification of Syllabus Suggested by?
All India Council for Secondary
Education*

The All India Council for Secondary-Education discussed the question of inclusion of English in the curriculum as a compulsory subject of study at the secondary stage of education at its 2nd meeting held on the 11th January 1956 and recommended that the following amendment to the scheme of study in the Secondary Education Commission's Report (pages 86-87 of the old edition) may be made:—

"Instead of A. 1 of the scheme of study in Secondary Education Commission Report page 86-87 insert the following:—

Group A—

- (i) The regional language or, 'the-Mother tongue', or, a composite-course of the mother tongue and classical language, or, a composite-course of regional language and classical language, or, a composite-course of regional language and mother tongue.

(ii) Hindi or English.

(iii) One modern Indian language other than the one taken under (i) and (ii).

This amendment makes study of three languages compulsory instead of two languages as envisaged in Secondary Education Commission's Report, but it does not make Hindi compulsory in non-Hindi areas.
