†[THE DEPUTY MINISTER FOR RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) The Engineer-in-Chief, Lighthouse Department, was in Italy for about six days only, and during this short time, he discussed with the Director General of Italian Lighthouse Service and other officials various questions connected with the new projects under construction in Italian waters, specially the project relating to the construction of a Lighthouse at Maloria which is reported to be situated 20 to 30 miles away from the shore on the northwest Italian coast. He also visited the navigational aids in the harbours of Naples and Genoa and also the workshop establishment at La Spezia. He visited the S.M.T. Radar Factory at Florence where several types of radar are being manufactured.

(b) The experience gained by him in the working of the Lighthouse system in Italy is being made use of in the development of Lighthouse system in India wherever possible.]

PRODUCTION OF GHEE

370. SHRI D. NARAYAN: Will the Minister for FOOD AND AGRICULTURE be pleased to state the quantity of ghee produced during 1954-55 and so far in the 1955-56 in each State in the country?

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI A. P. JAIN): The production of ghee in the country is estimated on the basis of the number of milch animals. **COMMITTEES IN THE INDIAN TELEPHONE
INDUSTRIES LTD., BANGALORE**

**GO SLOW MOVEMENT IN THE
CALCUTTA PORT**

372. **MOULANA M. FARUQI:** Will the Minister for TRANSPORT be pleased to state:

(a) how many times the stevedore labour and the decasualised shore labour at Calcutta Port resorted to go slow tactics during the year 1954-55; and

(b) what were their demands?

THE DEPUTY MINISTER FOR RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) Stevedore labour in the Calcutta Port resorted to go slow tactics during January to May 1954, and again in March, 1955 for about four days. The decasualised shore labour adopted go-slow tactics from the 12th November 1954 and resumed normal work from the 11th December 1954.

(b) The demands of the stevedore labour related to the principles to be observed in the selection of gangs for the monthly register from amongst the reserve pool workers and the registration of tally clerks under the Calcutta Dock Workers (Regulation of Employment) Scheme, 1951. The demands of the decasualised shore labour pertained to wages, allowances, registration of workers, gratuity, uniforms, filling of vacancies, and working conditions.
