SHRI M. VALIULLA: When is the installation of the other cranes likely to be completed?

SHRI O. V. ALAGESAN: It will be done immediately. It is a phased programme.

## RESERVE STOCK OF-FERTILIZERS IN STATES

**†\*98.** SHRI VIJAY SINGH: Will the Minister for FOOD AND AGRICULTURE be pleased to state whether there is any proposal under the consideration of Government for keeping reserve stock of fertilizers in the States"

THE MINISTER FOR AGRICUL-TURE (DR. P. S. DESHMUKH): The State Governments are responsible tor making arrangements for the storage and distribution of fertilizers. They have been advised to keep adequate reserve stocks.

SHRI BARKATULLAH KHAN: Has the Government called for information from the State Governments with regard to the construction made so far?

DR. P. S. DESHMUKH: I did not quite follow.

MR. CHAIRMAN: Have the Government obtained information from the State Governments as to what they have done in this matter?

DR. P. S. DESHMUKH: Yes, Sir. I have got complete information with regard to the number of retail depots and agents and whether they have had any complaints with regard to the adequacy or inadequacy of stocks.

**PROF.** G. RANGA: Are the Government doing anything to enable the State Governments to have the necessary storehouses for stocking these reserves?

THE DEPUTY MINISTER FOR COMMUNICATIONS Raj (Shri BAHADUR): (a) A request has been received.

(b) It is not possible to provide the circuit due to shortage of channels.

SHRI S. N. MAZUMDAR: Is it only due to the shortage of channels that it is not possible to provide the circuit or is there any other policy which the Government is following in this matter?

SHRI RAJ BAHADUR: I have said it in the reply to the question. We have not got spare channels. We have got 36 channels and all of them are occupied.

SHRI S. N. MAZUMDAR: Is the hon. Minister aware that this news agency has now entered into a combine with an American news agency, the U.P.A. and that the policy laid down by the Government was that no teleprinter facilities would be granted to foreign news agencies?

SHRI RAJ BAHADUR: So far as we are concerned, the Posts and Telegraphs Department is a commercial-cum-public utility department. If we get customers and we have got spare capacity, we shall definitely see.

SHRI S. N. MAZUMDAR: May I take it that the policy enunciated by Sardar Patel has now been abandoned by the Government?

SHRI RAJ BAHADUR: I am not aware of that enunciation of policy. I will only say that if it is there then our decision will be in consonance with that particular policy, that is,
