- (c) what are the reasons for sharp decline in growth rate in agriculture sector, during 2004-05; and
  - (d) what steps Government intends to take to improve the situation?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI S.S. PALANIMANICKAM): (a) and (b) As per the data released by the Central Statistical Organisation, the sectoral real growth rates in Gross Domestic product (GDP) at factor cost during 2000-01 to 2004-05 are as follows:

- (c) The sharp decline in growth rate of agriculture sector during 2004-05, was mainly due to the decline in the production of agricultural crops during the kharif season.
- (d) The Government has taken a number of measures to achieve higher growth of the economy, including the agriculture sector. These, *inter alia*, include emphasis on enhanced public investment, diversifying agriculture, promotion of public-private partnership for infrastructure development and facilitating growth in industries and services sector through an enabling policy environment. The various measures are expected to have a favourable impact on the economy.

## Under-invoicing by drug companies
