SHRI B. K. P. SINHA: On what grounds will you say that a firm is Indian or foreign? What are the criteria?

SHRI D. P. KARMARKAR: It has been our policy recently to insist upon having a majority Indian \mathbf{of} capital, except in such instances as the Oil Refineries in Bombay where we have departed from that principle. Otherwise, normally it is our policy to have only such firms in India as have a majority of Indian capital.
