SHRI S. N. MAZUMDAR: Is it not a fact that some Committee went into this question and submitted certain recommendations? Can the hon Minister enlighten us as to how far the recommendations of that Committee implemented or have been progress has been made in this matter till now?

SHRI LAL BAHADUR: I cannot say anything at present.

REDUCING THE STEEP GRADIENT OF THE RAILWAY LINE BETWEEN MAL JUNCTION AND MADARIHAT

\*313. SHRI R. THANHLIRA: Will the Minister for RAILWAYS be pleased to state whether Government propose to reduce the steep gradient of the railway line between Mal Junction and Madarihat Station on the North Eastern Railway?

THE MINISTER FOR RAILWAYS AND TRANSPORT (Shri BAHADUR): The work of easing the ruling gradient on a part of the section has already been completed.

SHRI ABID ALI: Yes. All the employees will remain and also the emoluments which they will be getting on the day of transfer will be guaranteed.

SHRI M. VALIULLA: Regarding item 3 regarding medical benefits to families, may I know as to what steps have been taken by the Government in this matter?

SHRI ABID ALI: There is some difficulty about finance. When the finance will be available, this question will be taken up.

SHRI M. VALIULLA: Regarding item 4-consideration of principles for the fixation of minimum wages under the Minimum Wages Act, are Government taking any steps to bring in amendments to give effect to resolution?

SHRI ABID ALI: Yes. I hope during the next session of the Parliament the amending Bill will be introduced.
