Pakistan. But I have not got the figure as demanded by the hon. Member.

Written Answers

SHRI H. P. SAKSENA: Does this amount of 300 crores of rupees include the amount that is due to India from Pakistan because of the- excess of the property left by the refugees in Pakistan as compared to what was left by refugees in India?

SHRI M. C. SHAH: That is excluded. There may be several hundred crores worth of properties left by the refugees from Pakistan. That is not included in these 300 crores of rupees. This is the share of the debt that we have taken over. Certain charges are to be paid, pensions have to be paid and so many things are there. There are other claims Slso advanced by Pakistan against India about the share of the Reserve Bank and this and that.

DIWAN CHAMAN LALL: May I ask my hon. friend to make the posi-tion quite clear whether these 300 crores of rupees are the only debt due from Pakistan on the partition of the country or whether it also includes certain other items that I specified in the previous question?

SHRI M. C. SHAH: I have not got all that information with me, because, as I said, amounts due from foreign Governments other than Pakistan are there. Only for the information of the hon. Member, I thought that there would be a suppTementSry question and so I enquired and approximately Rs. 300 crores are due to India from Pakistan. I cannot give the break-up just now.

SHRI M. VALIULLA: How much *C*-< it is admitted by the other countries?

SHRI M. C. SHAH: If this is admitted, then I would have given the figures. I say that they have not been determined.
