ment of the People's Republic of China. They have advised the Director General, Overseas Communications Service that as soon as the U.K. authorities take a decision to pay the amount to either of the two Governments the amount outstanding to India would be retained by them and paid to India. The matter has also been taken up with the Government of the People's Republic of China by the Indian Ambassador in Peking.

(b) The Indian Ambassador in Peking has informed that until the Government of the People's Republic of China come to some decision in regard to similar claims by other Governments they are not likely either to reject or admit the claim.]

THE DEPUTY MINISTER FOP COMMUNICATIONS (SHRI R_{AJ} BAHADUR): (a) Yes, Sir, a fire was noticed on the Port Wing Flap of the aircraft after it had made a belly landing and the passengers and crew had disembarked.

- (c) Fire, as already **mentioned, wu** noticed after the passengers and crew had disembarked and there was,

i-efore, no question of rescue.
