SHRI V. K. DHAGE: I do not think he said that, Sir. He said that he will make enquiries.

. Mr. DEPUTY CHAIRMAN: So far as he knows.

SHRI V. K. DHAGE: I saw it personally myself. I went there two months ago.

DR. K. L. SHRIMALI: As the hon. Member says that he knows it personally, I will make further enquiries into the matter but my information is that the temple is in a fairly strong condition.
