REHABILITATION OF DISPLACED PERSONS FROM EAST PAKISTAN

*429. SHRI M. VALIULLA: Will the Minister for REHABILITATION be pleased to state:

(a) whether any steps have been taken for sending displaced persons from East Pakistan for settlement in States other than West Bengal; and 3831

(b) if so, what is the response from the States so far?

THE MINISTER FOR REHABILITATION (SHRI MEHR CHAND KHANNA): (a) Yes.

(b) The response is encouraging. Offers of land have been received from the following State Governments:—

SHRI M. VALIULLA: May I know, Sir, how many refugees have gone to these places?

SHRI MEHR CHAND KHANNA: No one has gone there as yet. The land has been located and is being surveyed. If we are fully satisfied about the suitability of these lands then the refugees will be sent there.

SHRI M. VALIULLA: Are the facilities one and the same for persons who want to be settled in West Bengal and those who want to go away to Madras, or are they in any way more inducing?

SHRI MEHR CHAND KHANNA: As far as West Bengal is concerned, there is no question of inducement. Already about one lakh rural families have been settled there. In West Bengal no more land is available. So, we are trying to locate lands outside West Bengal, but we will see that an economic holding is allotted. In case

any follow-up organisation is required, that will be set-up to look after the difficulties of the displaced persons.

SHRI B. C. GHOSE: What is the total area of land that has been offered and whether Government have at all surveyed any of these lands in the other States?

SHRI MEHR CHAND KHANNA: The areas offered are:

Uttar Pradesh has agreed to take 500 families.

SHRI B. C. GHOSE: Have any of the lands been surveyed as yet and what is the estimate of the total number of refugees that may be settled on these lands if these are found suitable?

SHRI MEHR CHAND KHANNA: Some of the areas are under survey. What I intend to do in the matter is that next month I am proposing to call a conference of the Ministers of the eastern States and the Ministers of the States who have offered lands so that the whole plan can be finalised in the shortest period. After the quantum of the land is fully known, I shall be in a position to indicate the number of families that will be settled on those lands.

SHRI H. C. DASAPPA: May I know, Sir, how many families have been proposed to be settled in the Anda-mans and how many families have already been settled?

SHRI MEHR CHAND KHANNA: Though the question does not arise I will say that about 1,000 families have already gone to Andamarts and we are trying to send more.
