SHRI D. P. KARMARKAR: That is not governed by 51 per cent. rule. It is in respect of new industrial undertakings which we now sanction. As a general rule we don't allow any industrial company to operate unless it has a majority of Indian capital.

PROP. G. RANGA: When was this subsidiary company formed?

SHRI D. P. KARMARKAR: That was in 1922, subject to correction.
