CONSTRUCTION OF AIR BASES AROUND MARMAGOA

*397. SHRI N. D. M. PRASADARAO: Will the PRIME MINISTER be pleased to state whether it is a fact that air-bases are being constructed around Marmagoa?

THE PARLIAMENTARY SECRE-TARY TO THE MINISTER FOR EXTER-NAL AFFAIRS (SHRIMATI LAKSHMI MENON): According to reports, while the Portuguese have constructed aerodromes in Marmagoa (Goa), Daman and Diu, there is no indication that these are being turned into air bases.

CENTRAL AID FOR THE REMODELLING OF KURNOOL-CUDDAPAH CANAL

THE DEPUTY MINISTER FOR IRRI-GATION AND POWER (SHRI J. S. L. HATHI): (a) In connection with their for effecting permanent scheme improvements to the scarcity areas the Government of India have earmarked a sum of Rs. 5 crores for financing seventeen medium irrigation schemes of the Andhra State during the First Plan period. The scheme for the remodelling of the Kurnool-Cuddapah Canal is one of them.

(b) Loans to the extent of Rs. 74 lakhs (Rs. 4 lakhs during 1953-54 and Rs. 70 lakhs during 1954-55) have been given to the Andhra Government so far for financing these seventeen schemes.
