

PROF. G. RANGA: May I know, Sir, whether any efforts have been made to form co-operatives of the agriculturists there, so as to enable them to purchase these tractors from the Government?

DR. P. S. DESHMUKH: If my hon. friend refers to Madhya Bharat, the Central Government has not made any such effort, nor is it the duty of the Central Government to do it.

PROF. G. RANGA: But I want to know whether Government have any information at all about the position, either with the Madhya Bharat or with the Central Government. The hon. Minister said that the **Central** Government has not done any such thing, but have they any information as to whether the Government of Madhya Bharat has done anything in this direction?

DR. P. S. DESHMUKH: No, there are not many proposals of this sort.

(a) the number of derailments of goods trains and mixed passenger trains which have occurred so far in the year 1955;

(b) the number of wagons involved in those derailments;

(c) the value of goods damaged in those derailments;

(d) the total loss incurred by the Railways; and

(e) whether any enquiry has been made into the general causes of derailments and if so, what are the findings?

(a) The total number of derailments to goods and mixed trains which occurred during the period from 1st January 1955 to 31st July 1955 were as follows:

(d) The approximate cost of damage to Railway property was Rs. 490,317.

(e) An enquiry is held into every accident. Failure of Railway Staff and the failure of mechanical equipment were the two main causes, of these derailments.

(c) if the reply to part (a) above be in the negative, whether Government propose to make any such arrangements?]

SUPPLY OF RICE TO NEPAL

*419. SHRI M. VALIULLA: Will the Minister for FOOD AND AGRICULTURE be pleased to state:

(a) whether Government have supplied ten thousand tons of rice to the Government of Nepal; and

(b) if so when and on what terms this rice was supplied?

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI A. P. JAIN): (a) and (b). Government have agreed to supply 10,000 tons of rice as free gift to Nepal out of which 7,589 tons has already moved and 1,616 tons are under despatch. The balance will move on receipt of despatch instructions from the Nepal Government.

INTERNATIONAL TRAINING CENTRE ON
SOIL FERTILITY

*421. SHRI M. VALIULLA: Will the Minister for FOOD AND AGRICULTURE be pleased to state the expenditure incurred by Government on the International Training Centre on Soil Fertility jointly sponsored by the Government of India and the Food and Agricultural Organisation of the United Nations?

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI A. P. JAIN): The expenditure is not likely to exceed Rs. 12,000.
