GEOLOGICAL MAPPING BY THE GEOLOGICAL SURVEY OF INDIA

STATEMENT

(a) In the search for minerals, the irst step is systematic mapping which 'etermines the possibility and the ixistence of minerals in any particular region and serves as an essential tuide for further geological work. In fact, investigation for minerals in any particular area may only be taken up if the systematic mapping of the area yields encouraging results. By its very nature, it must be, therefore, a continuous process carried out from vear to year from region to region in the areas unmapped so far and it cannot, therefore, be said that systematic mapping has beefj concluded in any particular area.
