- (a) whether any paper manufacturing factory is proposed to be started at Dandeli in th<; North Kanara district of the Bombay State:
- (b) if so, whether any foreign capital is likely to be invested in that factory; and
- (c) whether the Central Government will give any assistance; and if so, what kind of assistance is proposed to be given?

THE MINISTER FOR INDUSTRIES (SHRI N. KANUNGO): (a) Yes, Sir.

- (b) No. Sir.
- (c) Apart from the usual facilities in connection with the import of machinery, chemicals, etc., no special assistance is proposed to be given by the Central Government.

SHRIMATI VIOLET ALVA: Sir, is it true that the concession to exploit the North Kanara forest and to set up a factory was given to one Shri Chaudhury some time ago by the Bombay State? May I also know, Sir, how much he has been paid, and when the proposed factory is coming into operation? May I also know, Sir, whether he will be an employee? If so, how much is he going to draw per month?

SHRI N. KANUNGO: There have been some concessions given by the Bombay Government, the exact nature of which is not known to us.

SHRIMATI VIOLET ALVA: May i know whether there are any M.Ps. or ex-M. Ps. as directors of the proposed factory? If so, may I know their names?

Oral Answers

SHRI N. KANUNGO: We do not know of any M. Ps. who are directors of the company.

SHRIMATI VIOLET ALVA: Sir, is it not a fact that Mr. G. D. Somani, M.P. and Mr. Ram Nath Podar, an ex-M.P., are directors? Are the Government not aware of that?

SHRI N. KANUNGO:. Government are not aware of that, because we have b?>en dealing with Mr. A. D. Chaudhury, who has obtained the licence.

SHRIMATI VIOLET ALVA: May I know whether the Government ever propose to exploit the North Kanara forest and set up a factory on their own, since there is so much scarcity of paper, and the Nepa mills have also been taken over by the Government?

SHRI N. KANUNGO: Forests are exploited by the State Governments. And in this case, the Bombay Government are primarily responsible for exploiting the forest.

DR. SHRIMATI SEETA PARMANAND: How far has the Government moved towards the setting up of a State Trading Corporation to sell paper?

SHRI N. KANUNGO: That is not necessary, because most of the requirements are met from indigenous sources and from imports.

DR. SHRIMATI SEETA PARMANAND: Is the Government aware that the Finance Ministry has mooted a proposal to set up a State Trading Corporation to sell the paper produced in the mills in this country?

SHRI N. KANUNGO: The Government "": not aware of it

SHRIMATI VIOLET ALVA: May I know whether Shri Chaudhury has filed the Prospectus with the Government?
