•12. SHRI M. GOVINDA REDDY: Will the Minister for EDUCATION be pleased to state:

- (a) whether it is a fact that Government are taking steps to publish suitable literature with a view to eradicating provincialism and com-munalism; and
- (b) if so, what are the details of the steps taken?

THE DEPUTY MINISTER FOR EDUCATION (DR. K. L. SHRTMALI): (a) Yes, Sir. Steps are being taken to publish literature with a view to creating inter-State understanding and eradicating provincialism and regionalism.

(b) This Ministry intends to publish brochures, in collaboration with the Ministry of Information and Broadcasting, one on each of the major States. Each brochure will describe the physical, social, economic and cultural characteristics of the State concerned as well as bring out its achievements and contribution to the total cultural and political pattern of the country.

SHRI M. GOVINDA REDDY: May I know the arrangements made to get the material for these brochures?

DR. K. L. SHRIMALI: So far the details have not been worked out. All that we have done is to ask the State Governments what cooperation they will give and how many brochures they will be prepared to purchase.

SHRI M. GOVINDA REDDY: May I know whether there is any officer specially deputed for this work?

DR. K. L. SHRIMALI: Naturally, it will be done by one of the officers in the Ministry.

SHRI M. GOVINDA REDDY: May I know if the Government of India have collected the material that is already there in the States?

Dr. K. L. SHRIMALI: That will be taken into account when the brochures are being prepared.

DEPUTY THE MINISTER FOR EDUCATION (DR. K. L. SHRIMALI): (a) and (b). The matter is still under consideration.

- SHRI M. GOVINDA REDDY: Sir. may I know what exactly is the matter under consideration?
- DR. K. L. SHRIMALI: The matter under consideration is this. We want to have the India Office Library which is in London, but the U. K. Government wishes to retain it.
- SHRI M. GOVINDA REDDY: Ir view of the statement made in the House of Lords that this library belongs exclusively to the Crown, is there any matter left for consideration, and if so, what is that matter?
- DR. K. L. SHRIMALI: The matter is under negotiation. As far as we are concerned, we are definitely of the opinion that the India Offica Library belongs to us, but the Government of the United Kingdom wishes to retain it. And the whole matter is under negotiation
- SHRI M. GOVINDA REDDY: But has not their claim been categorically refuted?
- Dr. K. L. SHRIMALI: As far as we are concerned, we have categorically refuted the claim of the U. K. Government.
