**LOW-COST BRITISH AIR-BRAKES FOR
WAGONS FOR INDIA**

*61. SHRI S. MAHANTY: Will the Minister for RAILWAYS be pleased to state:

(a) whether the Foreign Operations Administration of the United States of America has refused to permit installation of low-cost British air-brakes in 3,300 railway wagons which are being manufactured for India in America; if so, why; and

(b) how much extra cost will have to be incurred for installation of brakes of other make in their place?

THE DEPUTY MINISTER FOR RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) Government have no official information.

(b) Does not arise, as the Railway Ministry pay on the basis of the lowest international market price of a similar wagon.

SHRI S. MAHANTY: "Government have no official information". Have they any non-official information?

MR. CHAIRMAN: They have no information. That is what he means.

SHRI S. MAHANTY: Then why say 'official information'?

MR. CHAIRMAN: You ask the next question.

SHRI V. K. DHAGE: If they have no information with them they may make proper enquiries in the matter. They must at least say that they will enquire into the matter.

SHRI O. V. ALAGESAN: We are not interested.
