MODEL RULES UNDER THE PLANTATION LABOUR ACT

THE DEPUTY MINISTER FOR LABOUR (SHRI ABID ALI): (a), (b) and (c). According to available information, 9 State Governments have published the draft rules under the Plantations Labour Act for criticism. They are expected to be finalised shortly. The other 2 State Governments concerned are taking steps to publish the draft rules.

THE DEPUTY MINISTER FOR HEALTH (SHRIMATI M. CHANDRA-SEKHAR): (a) and (b). A statement showing the required information is laid on the Table of the Sabha.

SHRI M. GOVINDA REDDY: May I know what improvements have been effected after this was taken over by the Government?

SHRIMATI M. CHANDRASEKHAR: We are intending to increase the bed strength to about 214 by the 31st March 1956. I have got particulars here regarding the extension programme. It is a long list. If you permit me, I will read the list.

SHRI M. GOVINDA REDDY: It is not necessary, but has anything been done so far by way of improvement?

SHRIMATI M. CHANDRASEKHAR: To start with, there were only about 50 beds in the hospital. Now we are contemplating to increase the bed strength to 214. This itself will prove that we are thinking of improving the hospital.

SHRI M. GOVINDA REDDY: Has the number of patients also increased considerably since the Government took over this hospital?

SHRIMATI M. CHANDRASEKHAR: Certainly because of the Contributory Health Scheme. Even Class IV Government servants and their families

are being given medical relief. The number of patients has increased.

SHRI M. GOVINDA REDDY: Have the Government thought of increasing the number of the staff, both in regard to doctors as well as nurses, in addition to increasing the accommodation?

SHRIMATI M. CHANDRASEKHAR: We have actually increased the number of the staff.

SHRI JASPAT ROY KAPOOR: what are the nursing home charges per day?

SHRIMATI M. CHANDRASEKHAR: I am not able to give that answer.

SHRI N. D. M. PRASADARAO: Is the hospital well-equipped? Has it got X-Ray apparatus?

SHRIMATI M. CHANDRASEKHAR: It is proposed to be well-equipped. We are making all the arrangements for that.
