May I know if similar coaches are also manufactured in other railwav workshops? If so, how do the costs compare?

SHRI O. V. ALAGESAN: The integral type of coach is not manufactured elsewhere, either in the H. A. L. or in the other railway workshops.

SHRI H. C. DASAPPA: Of the materials that have gone into the production of these coaches, what percentage is manufactured locally and what percentage is imported from outside?

SHRI O. V. ALAGESAN: The first few coaches will be made out of assemblies made in the Schlieren Works in Switzerland. After one or two years, the percentage of components manufactured in Perambur will increase. To that extent, the components to be imported from the Schlieren Works will decrease.

SHRI H. C. DASAPPA: When shall we be in the happy position of manufacturing all the components at Perambur itself?

SHRI O. V. ALAGESAN: Perhaps in the third or fourth year of production.

SHRI LALCHAND HIRACHAND DOSHI: Will the hon. Minister please place on the Table the programme that has been chalked out for the manufacture of parts and components?

SHRI O. V. ALAGESAN: It has been decided roughly that so many coaches will be made up of parts imported from the Schlieren Works and so many of Indian parts in the first year, second year and so on.

SHRI M. VALIULLA: When will the Factory go into production?

SHRI O. V. ALAGESAN: It starts production now and will reach the full capacity In the course of four or Ave years.
