SHRI RAJ BAHADUR: It covers the expenditure of 50 hours of flying which means license for A class.

CONTINUANCE OF ENGINEERING SCHOOL AT ALLAHABAD

*529. MOULANA M. FARUQI: Will the Minister for COMMUNICATIONS be pleased to state what decision has been taken with regard to the continuance of the Engineering School at the Civil Aviation Training Centre at Allahabad beyond the end of February, 1955?

THE DEPUTY MINISTER FOR COMMUNICATIONS (SHRI RAJ BAHADUR): It has been decided to continue the Engineering School for a further period of three years beyond the 28th February 1955.

PROF. G. RANGA: How many are proposed to be trained here?

SHRI RAJ BAHADUR: 18 trainees for A and C licences came out in August 1953; another batch of 18 came out in November 1954. At present, we shall take another batch. So far 36 or 40 have been trained and we shall take another batch.

EM&H G. RANGA: Why is it that the number is so small—is it because so few people offer themselves for this advanced training or is it because of the limited capacity in the training schools?

SHRI RAJ BAHADUR: It is because of the limited capacity of the sc^ : and also the training is rather costly both to the organisation and to the trainees themselves.

DAKOTA CONVERSION COURSES FOR COMMERCIAL PILOTS

*530. MOULANA M. FARUQI: Will the Minister for COMMUNICATIONS be pleased to refer to page 19 of his Ministry's Report for the year 1954-55, and state whether the Dakota conversion courses mentioned therein have since been started for commercial pilot licensees and if so, what is the duration of those courses?

THE DEPUTY MINISTER FOR COMMUNICATIONS (SHRI RAJ BAHADUR): Yes, Sir, the Dakota conversion courses are being conducted regularly. The duration of the course is about 4 months.
