Oral Answers SHRI B. N. DATAR: They can ask questions only to the extent of either the Central List or the Concurrent List.

SHRI H. C. MATHUR: May I know, Sir, how control is exercised by the Home Ministry over the affairs of these States? What is the agency?

SHRI B. N. DATAR: Formerly, Sir, we had the Regional Commissioners before elections. Then we had various counsellors. Now, these counsellor! have been abolished, and the various Ministries concerned deal with the States' Ministries, so far as particular problems are concerned. And the supervision, to the extent it is necessary, is exercised by the various Ministries.

ABOLITION OF INTERNAL CUSTOMS **DUTIES IN PART 'B' STATES**

*170. SHRI H. C. MATHUR: Will the Minister for FINANCE be pleased to state:

- (a) whether any financial assistance has been given to any of the Part B States in connection with the abolition of internal customs duties; and
- (b) what is the loss of revenue to each State on this account and how this deficiency is to be made up?

THE MINISTER FOR REVENUE AND CIVIL EXPENDITURE (SHRI M. C. SHAH): (a) and (b). The net yield from internal customs duties during 1954-55 was estimated at Rs. 164 lakhs for Hyderabad, Rs. 313 lakhs for Rajasthan, Rs. 74 lakhs for Madhya Bharat and Rs. 10 lakhs for Saurash-tra. The State Governments were expected to cover the gap resulting from the abolition of these duties by developing other sources of revenue and curtailing administrative expenditure. In the case of Rajasthan and Madhya Bharat, the Government of India have agreed to give loans to meet the uncovered gap during 1955-56 estimated at Rs. 150 lakhs and BS. 46 lakhs res-

pectively, of which Rs. 75 lakhs have already been advanced to Rajasthan.

SHRI H. C. MATHUR: May I know,. Sir, the assistance which the Rajasthan Government demanded in this respect?

SHRI M. C. SHAH: They urged before the Finance Commission that they would not be able to replace these internal transit duties by other taxes. But the Commission did not make any recommendation. And therefore what we gave was after considering the whole matter.

SHRI H. C. MATHUR: Sir, I am afraid, my question has not been fully answered. My question is: What is the deficit and how is that deficit going to be made up?

SHRI M. C. SHAH: Rajasthan required loan assistance to the extent of Rs. 150 lakhs, for which a budget provision has been duly made. And out of this amount, Rs. 75 lakhs have already been given.

MR. CHAIRMAN: They asked for Rs. 150 lakhs and they were given Rs. 150 lakhs.

SHRI M. C. SHAH: That is for the Madhya Government, the Rajasthan Government, the Hyderabad Government and the Saurashtra Government, and not for the Central Government.

SHRI M. C. SHAH: The Madhya Bharat Government should see that they do not starve.

SHRI AKBAR ALI KHAN: May I know, Sir, the ratio of the amount given to the Hyderabad Government and the income that it draw from the customs?

SHRI M. C. SHAH: The Hyderabad Government drew from customs, in 1950-51 Rs. 4,24,00,000, in 1951-52 Rs. 4,62,00,000 in 1952-53 Rs. 3.95.00.000, in 1953-54 Rs. 3,02,00,000. Now from the Sales Tax they got in 1954-55 Rs. 3 crores, and in 1955-56 the budget estimate is Rs. 3,75,00,000, much more than what they realised in 1953-54.
