OVERSTAYAL IN INDIA BY FOREIGN TOURISTS

(b) if so, what is the number of such persons and what action Government took in the matter?

THE DEPUTY MINISTER FOR HOME AFFAIRS (SHRI B. N. DATAR): Since 1st January 1954 till the end of July 1955 for which period the information is readily available, the number of foreigners who came to India as tourists or on short term visas and whose cases for extension were referred to the Central Government is 74. Out of these extension was granted in 53 and refused in 14 cases. The remaining 7 cases are still under consideration. The number of cases in which the State Governments, who are also authorised to grant extension in certain circumstances, is not known.
