INDIAN TEXTILE DELEGATION'S VISIT TO CEYLON

(a) whether any Indian textile delegation visited Ceylon some time back;

(b) if so, the names of the projects for which the aid is sought;

(c) the amount of aid asked for; and

(d) the action taken by Government in the matter?

THE DEPUTY MINISTER FOR IRRIGATION AND POWER (SHRI J. S. L. HATHI): (a) No, Sir.

### PROSPECTING WORK IN KORBA COAL FIELD

\*197. SHRI RATANLAL KISHORILAL MALVIYA: Will the Minister for PRODUCTION be pleased to state:

(a) how long the work of prospecting the area has been going on in the Korba Coal fields, and what are the results and costs thereof so far; and

(b) when do Government expect to start extraction and despatch of coal from Korba?

THE MINISTER FOR PRODUCTION (SHRI K. C. REDDY): (a) The work of prospecting the area was begun by the Officers of the Central Government on the 30th May 1955 and is still in progress. Two bore-holes have been completed and a third is in progress. A report received from the Coal Commissioner shows that two coal seams have been located.

The expenditure so far incurred including all incidental charges is about Rs. 45,000.
