MR. CHAIRMAN: That is another . suggestion.

SHRI H. C. MATHUR: Is the lion. Minister aware that many of the ex-State Railway officers who were directly recruited and who are fully qualified—some have even foreign aegrees—have been rejpgated to Class II even though they worked for a number of years as gazetted officers?

9HRI LAL BAHADUR: That is so and that matter is being considered in connection with the question of the ex-State Government servants.

SHRI H. C. MATHUR: At present some of these officers are working in Class II and Class III. May I know what their position is going tD bs vis-a-vis the freshly recruited Assistant Engineers when they are made Bftrmanent?

SHRI LAL BAHADUR: The hon. Member will come to know about it only when our decision about which I have just now said will be announced.

SHRI H. C. MATHUR: I am only talking about these officers. When they have advertised these posts and when they are taking about 50 officers they must have come to a decision so far as these officers are concerned, and am I to understand that this is the sort of concession which is being given to the ex-State officers?

SHRI LAL BAHADUR: Let the question about the ex-State employees be decided first as to what would be their fate. When that has been decided then shall we be able to take a decision *vis-a-vis* these temporary engineers.

SHRI H. C. MATHUR: It is absolutely obvious that these officers have got to be Class I officers. So am I to understand that all the ex-State Railway officers will definitely be Class I officers?

SHRI LAL BAHADUR: No decision has so far been announced about the ex-State officers. As tk« hon, Member

said, they are in Class I as well as in Class II and he himself now suggests that all these temporary officers should be placed in Class I. One has to judge the suitability and other things even in regard to these temporary officers and then alone final decision taken.

## INCREASE IN STEAMER FARES

\*671. SHRI M. VALIULLA: Will th Minister for Transport be please to state whether the investigation in' the complaints regarding increase < the Steamer Fares between Calcut and places in Assam has been con pleted?

THE MINISTER FOR RAILWAYS AND TRANSPORT (.SHRI LAL BAHADUR): Ye . The report is under preparation.

SHRI M. VALIULLA: This question regarding the Increase of fares was raised about two years back and then it was said that the matter was under con ideration. May we know how long more they will take to decide the question?

SHRI LAL BAHADUR: I think the hon. Member is somewhat wrong in his statement. This committee was set up oaly in March 1954 and now the matter is not under consideration but the report is under consideration.

SHRI M. VALIULLA: The committee might have been set up last year, but the complaint is old. The representation was made to the Government more than two years back for reduction of steamer fares and still now no settlement has taken place. That was what I meant to say. And now there is the question of shipping companies asking for more freights and more fare, and the Government also is likely to consider it favourably I am given to understand. Even 50 may I know whether the steamer fares between Assam and Calcutta will be reduced or will they get no relief?

SHRI LAL BAHADUR: The hon. Member is confuting two things. The increase in freight which has been asked for is by the coastal shipping companies, not these steam naviga-tion companie". We are not at all concerned with the increase in freights which they might have suggested somewhere; they have not written to us.

SHRI M. VALIULLuri.: I am only speaking about the steamer fares between Calcutta and As^am. Will that not *come* under the scheme of increase in the fares demanded by the coastal shipping companies'

SHRI LAL BAHADUR: These are companies. I am talking of coastal hipping which is separate.
