THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRIA NARENDRA): No, Sir. The poverty alleviation programmes of the Ministry of Rural Development are being implemented to improve the economic condition and quality of life of the rural poor. These programmes are open for all the rural BPL families, however, preference is given to the SCs/STs and other weaker sections of the society who are comparatively more vulnerable.

Incentives to growers of bio-diesel plants

2497. SHRIMATI MOHSINA KIDWAI: Will the Minister of RURAL DEVELOPMENT be pleased to state:

(a) whether Government's attention has been drawn to the news item under the caption"Power Ministry Malls Sugarcane approach" for bio-diesel which appeared in Media;

(b) if so, what incentive Government propose to offer to the growers of bio-diesel plants and by when such incentives are likely to be announced; and

(c) if the answer to part(b) above is in negative, what are reasons thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (A. NARENDRA): (a) to (c) The news item referred to in the question appeared in The Statesman dated 5th September, 2004. This approach advocates growing of bio-diesel plants in advance before the required processing facilities are set up. For promotion of bio-diesel production, Jatropha curcas has been identified as a suitable plant for extensive cultivation. However, since this plant is a new introduction in the country and has no history of cultivation as a mono-crop and relevant data base on varieties, aronomic practices, productivity etc. is presently lacking, the Ministry of Rural Development has submitted a Detailed project Report (DPR) for approval of the Planning Commission to launch a demonstration project, under which Jatropha cultivation would be taken up on 4 lakh hectares in various States, primarily on degraded forest lands and Panchayat/community wastelands. If this demonstration project proves successful, Jatropha plantation would be taken up on a large
