SHRI BHUPESH GUPTA: May I know the amount procured by the Uttar Pradesh Government in this case?

SHRI M. V. KRISHNAPPA: If a separate question is put, I am prepared to answer.

SHRI H. C. MATHUR: The question is about the rate, at what rate wheat and rice are being procured and what is the quantity that has been procured?

SHRI M. V. KRISHNAPPA: I know the rate but about quantity I want a separate question. The rate is Rs. 10 per maund in the case of wheat, about Rs. 5-8-0 in the case of *jawar* and about Rs. 6 in the case of *bajra*.

EMPLOYEES' STATE INSURANCE SCHEME

•113. SHRI S. N. MAZUMDAR: Will the Minister for LABOUR be pleased to state:

(a) whether Government have received any complaints or suggestions from the All India Trade Union Congress about the implementation of the Employees' State Insurance Scheme in West Bengal;

(b) if so, what are the suggestions; and

(c) .what action" has "been taken by Government thereon?

THE DEPUTY MINISTER FOR LABOUR (SHRI ABID ALI) : (a) Central Government have received a copy of the communication sent to the Government of West Bengal by the West Bengal Committee of the All India Trade Union Congress on certain matters connected with the working of the Scheme.

(b) and (c). The Director General, Employees' State Insurance Corporation has already explained the position to the All India Trade Union Congress. A statement containing the required information is placed on the Table of the Sabha. [See Appendix IX, Annexure No. 20.] *I* SHRI S. N. MAZUMDAR: As regards item (1) in the statement, may I know whether the Government has any information as to the action taken by the Government of West Bengal in this matter?

to Questions

SHRI ABID ALI: Sir, this matter is to be attended to by the West Bengal Government and we have no definite information as to what has been done.

SHRI S. N. MAZUMDAR: Has the Government any information regarding the fact that the regional authorities there have a different interpretation on this matter?

SHRI ABID ALI: Sir, I do not think that it can be so.

SHRI S. N. MAZUMDAR: As regards (7), may I know Whether the Government has any information as to how the matter stands now?

SHRI ABID ALI: "Arrangement for treatment of emergency cases": This also is to be attended to by the Government of West Bengal and we have stated that they will no doubt clarify the position.

SHRI S. N". MAZUMDAR: May I know whether any other suggestion, besides the points given in the statement, have been submitted to the Government, suggestions mainly pertaining to the fact that hardships' experienced by the workers in other areas where this scheme has been implemented should be avoided here?

SHRI ABID ALI: Yes, Sir, the benefit of the experience gained in other States will be there while implementing the scheme in West Bengal.

SHRI S.N. MAZUMDAR: May I know what the specific points are?

SHRI ABID ALI: Let the hon. Member give separate notice; I shall certainly supply the information.

SHRI S. N. MAZUMDAR: Is it not a fact, Sir, that one of the suggestions is that the workers have to undergo long delay in getting medical certificates and X-ray plates and that they have to undergo a long process of dilatory treatment at the hands of different authorities and that this should be avoided here?

SHRI KHANDUBHAI DESAI: Sir, the scheme was introduced in the city of Bombay about 2& months ago and the difficulties experienced there are being studied by the authorities in Bombay. All those things have been discussed with the representatives of employers and employees as well as the medical profession and the difficulties are being removed gradually.

DELHI. SUBURBAN RAILWAY
