

II. "C" Class Licence.—This operates within the boundaries of a state for which it is granted to a person who is not entitled to an "A" class licence or being entitled to an "A" class licence does not apply for it or is refused an "A" class licence.

III. "H" Class Licence.—Every person who wants to deal in hand ginned cotton within a State has to obtain an "H" class licence.]

LOANS FOR THE EXPANSION OF EDUCATIONAL INSTITUTIONS IN WEST BENGAL

360. DR. R. P. DUBE: Will the Minister for REHABILITATION be pleased to state:

(a) how much of the loan of Rs. 80 lakhs given to the West Bengal Government up to the 31st March, 1952 for the expansion of educational institutions outside Calcutta has so far been recovered; and

(b) the rate of interest payable on this loan and the number of years up to which it is repayable without interest?

THE MINISTER FOR REHABILITATION (SHRI MEHR CHAND KHANNA):

(b) The loan of Rs. 80 lakhs was given to the Government of West Bengal in 3 instalments of Rs. 20 lakhs 50 lakhs and 10 lakhs at the rate of $3\frac{1}{4}$ per cent., $3\frac{1}{2}$ per cent. and $3\frac{3}{4}$ per cent. respectively. No free period of interest is allowed.
